Airport Authority

One expiration as of January 1, 2018

Five year term. Five member limit. Meet 2nd Wednesday @ noon at the Airport. Must be a taxpayer, maintain a business in, or be a citizen of the municipality into which one or more of the Authority's Projects extends. Majority of members shall be citizens residing in the municipality.

Board of Code Appeals

One expiration as of January 1, 2018

Shall consist of members who are qualified by experience and training to pass on matters pertaining to building, construction, and are not employees of the jurisdiction. (Act 45 of 1999 PA Dept. of Labor & Industry and Article 1707) Members appointed by governing body and shall hold office at its pleasure.

Board of Health

One Vacancy.

Five year term. Five members. Meet as needed. Shall be residents of the City except in case of physicians, who shall have an office in the City. Re-organize 1st Monday in January. Enforces the laws of the Commonwealth and the rules, regulations and orders of the State Dept of Health.

Civil Service Commission

One Vacancy.

Six year term. Three members. Meet as necessary. Responsible for preparing, adopting and administering civil service rules and regulations for the City of Titusville. Set the process for testing, selection and appointment of fire and police department personnel. Must be a registered elector of the City.

Housing Authority

One expiration as of October 9, 2017

Five year term. Five members. Meet 3rd Tuesday following the 3rd Monday at 3:00 p.m. at Central Towers. Follow the regulations of the Department of Housing and Urban Development. Provide housing to low and very low income individuals who need safe, sanitary, and affordable housing. Members shall be residents of the City.

Benson Library Board

One expiration as of January 1, 2018

3 Year Term - 7 Members. Meet 3rd. Tuesday at 4:30 p.m. at Library. Two City appointments.*Other members are appointed directly by the Board. (By-laws of the Library Board) Oversee the care and management of the Library, including the grounds, building, and contents.

Planning Commission

One Vacancy.

Four year term. Five members. Must be a resident of the Municipality. Meet on the 2nd and 4th Thursdays of each month at 6:00p.m.at City Hall unless otherwise advertised. The voting meeting will be on the 2nd Thursday and the work session on the 4th. The Commission makes recommendations concerning the adoption or amendments of the Zoning Ordinance; recommends approval or denial of subdivision requests; and prepares, recommends, and administers the Comprehensive Plan for development of the City.
