

**NOTICE OF 2<sup>nd</sup> PUBLIC HEARING**  
**CITY OF TITUSVILLE, PENNSYLVANIA**  
**FY 2019 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM**

The City of Titusville intends to apply to the Department of Housing and Urban Development for funding under the Community Development Block Grant (CDBG) Small Cities Program, a federally funded program administered by the State. The City conducted its first public hearing on Tuesday, June 25, 2019 to discuss the CDBG program in general, the needs of the City of Titusville, performance under the previously funded CDBG program years, and to discuss the required Three Year Community Development Plan. There was no public input at the hearing.

Based on an assessment of the City's needs, the City is proposing to undertake the following activities for Fiscal Year 2019. These activities will not result in the displacement of families or individuals and at least 51% of the beneficiaries of the proposed projects will be low and moderate income persons. National Objective - 24 CFR 570.208 Area Benefit % LMI (Entire City) = 53.68%.
