**505.01 DEFINITIONS.**

For the purposes of this article, except where the words in the context used clearly indicates a contrary intention, the following words and phrases shall be defined as follows:

(a) "Abandoned vehicle" means:

- (1) Any motor vehicle that is left unattended on a public property within the City for more than ninety-six hours, a motor vehicle that has remained illegally on public property for a period of more than ninety-six hours or a motor vehicle that has remained on private property without the consent of the owner or person in control of the property for more than ninety-six hours;

- (2) Any motor vehicle which has been parked, stored or left in a wrecked, junked, stripped or abandoned condition on private property in a place where its presence constitutes a hazard on such private property, or where such vehicle constitutes an aesthetic nuisance on such private property and such vehicle has remained on such private property in such condition for a period in excess of fifteen days, unless such parking or storage is authorized in conjunction with a business properly operated, pursuant to zoning and other laws of the City. Any vehicle lacking either a current Pennsylvania Department of Revenue inspection sticker or current license plates shall be presumed to be an abandoned vehicle.
- (b) "Police Department" means the Police Department of the City.
- (c) "Person" means every natural person, association or corporation. Whenever used in any clause prescribing and/or imposing a penalty, the term person, when applied to associations or corporations, includes the owners or officers thereof.

#### **505.02 ABANDONED VEHICLE PROHIBITED.**

No person shall park, store or leave any motor vehicle of any kind in such a way as it becomes an abandoned vehicle within the City.

#### **505.03 NOTICE TO REMOVE ABANDONED VEHICLES.**

If any member of the Police Department finds that a violation of this article exists, a member of the Police Department shall notify the owner of the vehicle, if abandoned on public property, or the owner of the property, if abandoned on private property, of the violation, and order the owner of such motor vehicle, if abandoned on public property, to remove the vehicle within twenty-four hours from the date of such notice. If located on private property, the owner shall be ordered to remove such vehicle within twenty-four hours from the date of such notice.

#### **505.04 SERVICE OF NOTICE.**

Notice shall be given by personal service or by registered mail to the last known address of the violator. In the event that on diligent search, the address of either the property owner or motor vehicle owner cannot be ascertained, the posting of such notice or copies thereof on the real property, motor vehicle, structure or area immediately adjacent thereto shall constitute sufficient notice.

#### **505.05 REQUEST FOR HEARING; FEE.**

Within five days of receipt of the notice, the party or parties affected may request a hearing with the City Manager by filing a written request with the Chief of Police. The owner of the motor vehicle shall, with the request, file a fee as established by Council to cover the costs involved in the hearing. The Chief of Police, after such hearing, shall affirm, withdraw or modify the notice as directed by the City Manager. The City Manager shall have authority only to extend time for removal.

**505.06 VEHICLE REMOVAL PURSUANT TO NOTICE AND ORDER.**

If a hearing is not requested within five days of receipt of the notice of the violation, the parties affected shall proceed to remove or have removed the motor vehicle in question from the property in question in accordance with the notice and order.

**505.07 NOTICE OF HEARING.**

On proper request, a hearing on the matter shall be given forthwith, and where more than one party is involved, it shall be the duty of the party requesting the hearing to notify all other parties affected or interested of the time and place of the hearing.

**505.08 CHARGES FOR REMOVING VEHICLES; LIEN AGAINST OWNER.**

If the violation complained of has not been remedied within the period as required by this notice or the order if a hearing is had, the City shall, through its own agents, contractors and/or employees remedy the violations by removing the vehicle and charging the cost thereof to the real property owner on whose property the vehicle is located, or if located on public property to the owner of the vehicle. The costs shall, after a proper demand and refusal or a failure to pay, after thirty days, constitute a judgment lien against the individual involved and in the case of private property, a lien against the realty, which shall be filed by the City Solicitor.

**505.09 EMERGENCY REMOVAL OF VEHICLES WITHOUT NOTICE.**

Nothing in this article shall prevent the Chief of Police or his duly authorized officers from removing from private property without notice any attended or unattended motor vehicle, the presence of which constitutes a hazard or threat to the life, health, safety, welfare and morals of the residents of the City, which is immediately dangerous and, in the opinion of the Chief of Police or authorized officers, constitutes a nuisance which gives rise to the existence of emergency conditions.

**505.10 REMOVAL PROHIBITED WHEN OWNER PLANS IMMEDIATE REMOVAL.**

No vehicle shall be removed under the authority of this article if, at the time of the intended removal thereof, the owner or person for the time being in charge of such vehicle is present and expresses a willingness and intention to remove such vehicle immediately.

**505.11 VEHICLE DISPOSITION; USE OF MONEYS.**

Lienholders of record shall be notified and disposition by sale or otherwise shall be made of valueless, abandoned vehicles. The amount received by the City shall be applied to the costs or any fine involved in such violation.

**505.99 PENALTY.**

Whoever violates any section of this article shall, upon conviction, be fined not less than ten dollars (\$10.00) nor more than three hundred dollars (\$300.00), and in default of payment thereof, shall be imprisoned for not more than thirty days. Each day's failure to comply with the order of the Chief of Police shall constitute a separate offense for each vehicle in violation thereof.

**510.01 NO TURN ON RED INTERSECTIONS DESIGNATED.**

At the following intersections, no turn on red sign shall be erected, or ratified if previously erected, and traffic headed in the direction indicated shall be prohibited from making a right turn on a steady red signal:

**511.01 DIAMOND STREET.**

No eastbound vehicular traffic on Diamond Street shall make a u-turn onto Central Avenue at the intersection of the two streets so as to proceed in the opposite direction.

**511.02 CENTRAL AVENUE.**

No eastbound or westbound traffic on Central Avenue between South Drake Street and Martin Street shall make a u-turn so as to proceed in the opposite direction.

**511.03 ERECTION OF SIGNS.**

Appropriate signs indicating that no eastbound traffic on Diamond Street may make a u-turn onto Central Avenue and that no eastbound or westbound traffic on Central Avenue may make a u-turn shall be erected on Diamond Street and Central Avenue. The signs shall be erected and maintained in conformance with the manual and regulations of the Pennsylvania Department of Transportation.

**511.99 PENALTY.**

(a) Any person who violates any provision of this article shall be sentenced, upon conviction, to pay a fine of twenty-five dollars (\$25.00).

(b) Upon plea and proof that any person is unable to pay any fine or costs imposed under this article, a court may, in accordance with the Pennsylvania Rules of Criminal Procedure, order payment of the fine and costs in installments and shall fix the amounts, times and manner of payment.

(c) Any person who does not comply with an order entered under this section may be imprisoned for a number of days equal to one day for each ten dollars (\$10.00) of the unpaid balance of the fine and costs.

**513.01 CENTRAL AVENUE.**

(a) Central Avenue, from its intersection with Spring Street to the west side of its intersection with Diamond Street, is hereby designated as a one-way street for vehicular traffic moving from east to west.

(b) All vehicles shall proceed on the aforesaid section of Central Avenue as designated in subsection (a) hereof in a westerly direction. No person shall operate a vehicle on such portion of Central Avenue in an easterly direction.

(c) All vehicles may park according to law in the places designated on either the north or south side of the aforesaid section of such street, provided such vehicles shall be headed in a westerly direction, and further provided that vehicles shall be subject to the provisions of the parking meter ordinances of the City.

**513.02 SPRING AND DIAMOND STREETS.**

(a) Spring Street, from its intersection with West Central Avenue to the west side of its intersection with Franklin Street, and Diamond Street, from its intersection with Franklin Street to its intersection with Central Avenue, are hereby designated as one-way streets for vehicular traffic moving from west to east.

(b) All vehicles shall proceed on that section of the streets designated in subsection (a) hereof in an easterly direction. No person shall operate a vehicle on any portion of such streets in a westerly direction.

(c) All vehicles may park according to law in the places designated on either the north or south side of such section of such streets, provided such vehicles shall be subject to the provisions of the parking meter ordinances of the City.

**513.03 SOUTH FRANKLIN STREET.**

**513.04 EXCHANGE ALLEY.**

(a) All vehicular traffic on Exchange Alley shall proceed in a southerly direction only, between West Central Avenue and West Spring Street.

(b) All vehicular traffic shall proceed in a northerly direction only on that segment of Exchange Alley southerly from its intersection with West Spring Street.

**513.05 PROSPECT STREET.**

**513.06 MAY AVENUE.**

All vehicular traffic on May Avenue shall operate in a southbound direction only. No person shall operate a vehicle on May Avenue in a northerly direction.

**515.01 DEFINITIONS.**

The word "vehicle" when used in this article means every device in, upon or by which any person or property is or may be transported or drawn upon a highway.

**515.02 SPEED LIMIT.**

(a) No person shall drive or operate a vehicle in excess of twenty-five miles per hour on any street or alley which lies within the corporate boundaries of the city, except as otherwise provided herein. (Ord. 1962. Passed 10-17-88; Ord. 3048. Passed 7-23-01.)

(b) No person shall drive or operate a vehicle in excess of thirty miles per hour on that segment of Brook Street in the City which lies between the east line of North Franklin Street and the municipal boundary of the City.

- (c) No person shall drive or operate a vehicle in excess of thirty-five miles per hour:
- (1) On that segment of Smock Boulevard which lies between the south line of Bloss Street and the municipal boundary of the City.
  - (2) On that segment of St. John Street which lies between the west line of North Franklin Street and the east line of South Perry Street;
  - (3) On that segment of South Perry Street which lies between the north line of St. John Street and the south line of Spring Street;
  - (4) On that segment of Union Street which lies between the west line of North Franklin Street and the east line of North Perry Street; and
  - (5) On that segment of Church Run Road which lies between the north line of Union Street and the municipal boundary of the City.

- (d) No person shall drive or operate a vehicle in excess of forty miles per hour:
- (1) On that segment of Main Street which lies between the municipal boundary of the City on the east to a point 249 feet west of the west line of Lynn Street; and
  - (2) On that segment of Drake Well Road which lies between the west line of Allen Street and the east line of South Drake Street.

- (e) A 15 mile per hour school zone speed limit shall be imposed and in effect during the Titusville Area School District school year during the hours of 7:40 a.m. to 8:20 a.m. and from 11:00 a.m. to 12:30 p.m. and from 3:00 p.m. to 3:30 p.m. Monday through Friday on the following streets:
- (1) Spruce Street between a point 200 feet west of its intersection with Drake Street and a point 250 feet east of its intersection with North Kerr Street.
  - (2) Walnut Street between a point 225 feet west of its intersection with Drake Street and a point 200 feet east of its intersection with North Kerr Street.
  - (3) Drake Street between a point 225 feet south of Walnut Street and a point 285 feet north of Spruce Street.
  - (4) North Kerr Street between a point 225 feet south of Walnut Street and the intersection of North Kerr Street with Elm Street.
  - (5) Linden Street between North School Street and North Kerr Street.
  - (6) School Street between East Spruce Street and Linden Street.

- (f) A 15 mile per hour school zone speed limit shall be imposed and in effect during the Titusville Area School District school year during the hours of 7:40 a.m. to 8:20 a.m. and from 11:00 a.m. to 12:30 p.m. and from 3:00 p.m. to 3:30 p.m. Monday through Friday on the following streets:
- (1) Kerr Street between the centerline of Water Street and a point 650 feet north on Kerr Street.
  - (2) Brown Street between the centerline of Central Avenue and a point 1,350 feet south on Brown Street.
  - (3) Water Street between Brown Street and a point 1,100 feet west on Water Street. (Ord. 3030. Passed 12-18-00.)
- (g) A 15 mile per hour school zone speed limit shall be imposed and in effect during the Titusville Area School District school year during the hours of 7:40 a.m. to 8:20 a.m. and from 11:00 a.m. to 12:30 p.m. and from 3:00 p.m. to 3:30 p.m. Monday through Friday on the following streets:
- (1) West Main Street between a point approximately 250 feet west of Washington Street and a point approximately 250 feet east of North Franklin Street.

**517.01 TRUCKS OVER 11,000 POUNDS PROHIBITED ON CERTAIN STREETS.**

No person, copartnership, association or corporation or his or its servants, agents or employees shall operate a truck or other motor vehicle loaded or otherwise having a gross weight exceeding 11,000 pounds on any one of the following streets: Walnut Street, Spruce Street, Main Street to its intersection with East Central Avenue, West Elm Street and West Bloss Street, Washington Street from its intersection with Main Street North.

**517.02 CERTAIN LEFT TURNS PROHIBITED.**

No person, copartnership, association or corporation or his or its servants, agents or employees operating a truck or other motor vehicle loaded or otherwise having a gross weight exceeding 11,000 pounds shall make a left turn from East Central Avenue onto South Franklin Street at the intersection of Central Avenue and Franklin Street.

(a) The City may issue permits for the movement of vehicles of weights in excess of the restrictions posted and may require such undertaking or security as it deems necessary to cover the cost of repairs and restoration which may be necessitated by the permitted movement.

(b) Such permits may be issued if the City determines that:

- (1) For all practical purposes, the vehicle or combination can reach its destination only via the posted bridge; and
- (2) Analysis of the number of axles, axle weights, distance between axles, height, width and other data indicates that the vehicle or combination shall not have a detrimental effect on the bridge.

(c) Administrative fees. An administrative fee shall be charged for the issuance of each permit discussed in this section, and a check for the applicable fee shall be included with the application. The fee shall be for a single trip - once in each direction - or for a series of single trips during a twelve-month period or an unlimited number of trips during a three-month period.

**519.99 PENALTY.**

**521.01 MAXIMUM CONTINUOUS 24 HOUR STREET PARKING.**

No person shall park a registered vehicle on any street of the City for a continuous period of more than twenty-four hours.

**521.02 EMERGENCY NO PARKING AUTHORIZED; PUBLICATION OF NOTICE.**

In time of emergency caused by flood, excessive snow or other catastrophe, the City Manager may publish in The Titusville Herald the names of other streets upon which it is illegal to park during the time of such emergency. This publication shall be once each day during the period of the emergency. (Ord. 1375 § 3. Passed 4-7-52.)

**521.03 TOWING AND IMPOUNDING OF VEHICLES.**

Under the authority granted to the cities of the Third Class by the Pennsylvania Vehicle Code Section 6109(a)(22), the City of Titusville shall have the authority to remove and impound vehicles that are parked in violation of any of the sections of Article 521 of the Codified Ordinances of the City of Titusville or any other provision of the Codified Ordinances of the City of Titusville. Such towing and impoundment shall be conducted as follows:

- (a) Designation of Approved Storage Garages; Bonding; Towing and Storage. Removal and impounding of vehicles under this article shall be done only by approved storage garages that shall be designated from time to time by the Council. Every such garage shall submit evidence to the Council that it is bonded or has acquired liability insurance in an amount satisfactory to the Council as sufficient to indemnify owners of impounded vehicles against loss or damage to those vehicles while in the custody of the garage keeper for the purpose of towing or storage. The approved storage garage shall submit to Council its schedule of charges for towing and storage of vehicles under this article, and when the schedule is approved by Council, those charges shall be adhered to by the approved storage garage. No different schedule of charges shall be adopted without approval of the Council, and no different charges shall be demanded of or collected from any person whose vehicle is removed or impounded under this article by an approved storage garage. Council shall delete from its list of approved storage garages any garage that makes any unapproved charges in connection with any vehicle removed or impounded under this article.
- (b) Notification of Removal and Impounding. Within twelve (12) hours from the time of removal of any vehicle under authority granted by this article, notice of the fact the vehicle was removed shall be sent by the Police Department to the owner of record of the vehicle. The notice shall designate the place from which the vehicle was removed, the reason for its removal and impounding and the garage in which it was impounded.
- (c) Records. The Police Department shall keep a record of all vehicles impounded and shall be able, at all times, to furnish the owners or agents of the owners thereof with information as to the place of storage of such vehicle.
- (d) Restrictions Upon Removal. No vehicle shall be removed under the authority of this section if, at the time of the intended removal thereof, the owner or person for the time being in charge of such vehicle is present and expresses a willingness and intention to remove such vehicle immediately.

**521.04 REDEMPTION OF IMPOUNDED VEHICLE; PAYMENT OF FINES AND CHARGES.**

(a) Before any owner may reclaim his vehicle which has been placed in the City pound, he shall pay any fine or fines levied against him for illegal parking, and in addition thereto the sum of one dollar (\$1.00) for sending the registered notice and also the garage charges which have been placed against the vehicle for storage.

(b) Effect of Payment of Towing and Storage Charges. The payment of any towing and storage charges authorized by this article shall, unless payment is made under protest, be final and conclusive and shall constitute a waiver of any right to recover the money so paid. If payment of any towing or storage is made under protest, offender shall be entitled to hearing before the local District Justice, in which case such defendant shall be proceeded against and shall receive such notice as is provided in the Pennsylvania Vehicle Code in other cases of summary offenses and shall have the same rights as to appeal and waiver of hearing. Payment of towing and storage charges shall not relieve the owner or driver of any vehicle from liability for any fine or penalty for the violation of the provision of this chapter for which the vehicle was removed or impounded. (Ord. 3042. Passed 3-12-01.)

**521.05 PARKING PROHIBITED 2 A.M. TO 6 A.M.**

No person shall park any vehicle on the following streets between the hours of 2:00 a.m. and 6:00 a.m.:

Central Ave. from W. Spring St. to Martin St., with the exception of the north side of the 400 block of W. Central Ave. along which parking shall be permitted during said hours.

Diamond St. from Spring St. to Central Ave.

**521.051 PARKING RESTRICTIONS IN SCHOOL AREAS.**

(a) No person shall park any vehicle, other than a school bus authorized to deliver and pick up students, between the hours of 7:30 a.m. and 3:30 p.m. on the following streets:

- (1) Drake Street - East side from the point of intersection with Walnut Street to the point of intersection with Spruce Street.
- (2) Kerr Street - West side from the point of intersection with Walnut Street to the point of intersection with Spruce Street.
- (3) Spruce Street - Both sides from the points of intersection with Kerr Street to the points of intersection with Drake Street.
- (4) Main Street - South side beginning at a distance of 130 feet east from the east curb line of North Washington Street and extending for a distance of 122 feet easterly.
- (5) Second Street - East side from the point of intersection with Main Street north for a distance of 100 feet.

(b) No person shall park any vehicle between the hours of 7:30 a.m. and 3:30 p.m. on the following streets:

- (1) Drake Street - West side from the point of intersection with Main Street to the point of intersection with Walnut Street.
- (2) Kerr Street - West side from the point of intersection with Main Street to the point of intersection with Walnut Street.
- (3) Walnut Street - On both sides from the points of intersection with Kerr Street to the points of intersection with Drake Street.
- (4) Notwithstanding the parking restrictions set forth in subsection (b)(3) hereof, vehicles may stop for periods not in excess of five minutes for the pickup and discharge of passengers on Walnut Street only, between 7:30 a.m. and 8 a.m. and between 3 p.m. and 3:30 p.m., provided that such vehicles pull to the curb and do not pick up or discharge passengers from the roadway.

(c) No person shall park any vehicle between the hours of 7:30 a.m. and 3:30 p.m. on the following streets:

- (1) Washington Street - East side from the point of intersection with Cherry Street to the point of intersection with Main Street.
- (2) Main Street - South side from the point of intersection with Washington east for a distance of 130 feet.
- (3) Main Street - North side from the point of intersection with Convent Street to the point of intersection with Second Street.
- (4) Notwithstanding the parking restrictions set forth in subsections (c)(1) through (3) hereof, vehicles may stop for periods not in excess of five minutes between the hours of 7:30 a.m. and 8:15 a.m. and between the hours of 2:45 p.m. and 3:30 p.m. solely for the pickup and discharge of passengers, provided such vehicles pull to the curb and do not allow the pickup or discharge of passengers from the roadway.

(d) No operator of a vehicle shall discharge or pick up or permit the pickup or discharge of passengers from the roadway at the following locations:

- (1) Water Street - On both sides from the point of intersection with Brown Street west for a distance of 1,000 feet.
- (2) Kerr Street - On both sides from the points of intersection with Water Street to the points of intersection with Spring Street.

(e) The above parking restrictions shall not be in force on Saturdays, Sundays, holidays officially recognized by the Titusville Area School District, and on those days during the months of June, July and August when the schools of the Titusville Area School District are not in session. **522.01 PROHIBITED PARKING PLACES.**

No person shall park a motor vehicle:

- (a) On the roadway side of any vehicle stopped or parked at the edge or curb of a street (double parking);
- (b) Within fifteen feet of a fire hydrant;
- (c) In front of a public or private driveway;
- (d) On a sidewalk;
- (e) Within twenty feet of an intersection or on a crosswalk;
- (f) Within fifty feet of the nearest railroad track unless a meter space is provided;
- (g) More than twelve inches from the curb or edge of a roadway;
- (h) On two-way streets other than in the direction of travel for that side of the street;
- (i) At any place where official signs prohibit parking, including but not limited to, a hotel zone, a bus zone, a doctors' parking zone and a theater zone.

- (j) At any location which blocks free and unimpeded travel along any public alley, street or roadway.

**522.02 HANDICAPPED PARKING.**

(a) There is hereby created in the City of Titusville specific parking spaces to be determined and located which will be available only for parking motor vehicles bearing a "handicapped" or "severely disabled veteran" vehicle registration plate or which displays a "handicapped" or "severely disabled veteran" parking placard as such are prescribed by the Pennsylvania Motor Vehicle Code and are used for transportation of a handicapped person or severely disabled veteran. In such instances, parking shall not be limited to sixty minutes. Such license plate must be affixed to the vehicle or such placard must be readily visible from without the vehicle.

(b) City Council may from time to time when off-street parking is not available designate on-street handicapped parking spaces as near as practical to the residence of a handicapped person or a severely disabled veteran upon the written application of any such person and payment to the City of the costs to install the signage. The application shall set forth the make, model and license plate number of the applicant's vehicle. Following erection of appropriate handicapped signage in accordance with the Motor Vehicle Code, that space may only be used by persons who are in fact disabled persons or severely handicapped veterans in compliance with subsection (a) hereof. Such spaces shall not be solely for the person who made the request. The City shall be under no obligation to create such spaces, but may do so in its sole discretion considering all circumstances.

(c) Such handicapped parking spaces described in subsection (a) hereof or in any other area within the City either on private or public property may be made, removed, approved or disapproved by simple resolution. The designated handicap parking space shall become effective upon erection by the person who requested the space of appropriate signage in accordance with the Motor Vehicle Code.

(d) Should the holder of a permit for a handicapped parking space relocate to another residence within the City, the permit and the signage may be transferred to a new location within the City upon application to and approval by the City Manager. A relocation fee of \$50.00 shall be charged for the transfer of a handicapped parking space.

(e) Owners of private commercial property using that property for the invitation to the public in general may likewise establish handicapped parking spaces in accordance with this section, and with approval of the Chief of Police. Such spaces shall have erected thereon signs indicating the restricted type parking spaces in accordance with the Motor Vehicle Code. Thereafter, violations as provided for herein for the unauthorized use may be enforced as a violation of this section. The owner must erect signs in accordance with the Motor Vehicle Code; the erection of such signs shall be deemed to be a dedication by the owner during the time when the sign is present that space is devoted to handicapped parking as defined and circumscribed herein. (Ord. 3013. Passed 8-21-00.)

**522.99 PENALTY.**

(a) Whoever violates any provision of subsections (a), (b), (c), (e) or (f), of Section 522.01 shall be fined \$10.00 plus costs of prosecution, and in default thereof, shall be imprisoned not more than 5 days. (c) Any person found to have parked a vehicle in a designated handicap parking space whose vehicle either does not contain the appropriate tag or plate or has not been utilized to transport a handicapped person or severely disabled veteran shall pay a waiver penalty to the City of Titusville as provided in Section 525.09 of the Codified Ordinances of the City of Titusville; if the waiver penalty is not paid within the time limits set in Section 525.09, the violator shall be subject to the penalties provided in Section 525.99 of the Codified Ordinances of the City of Titusville. (Ord. 3013. Passed 8-21-00.)

(d) Whoever violates any provision of subsections (i) or (j) of Section 522.01 shall be fined fifteen dollars (\$15.00) plus costs of prosecution and in default thereof, shall be imprisoned not more than five days.

**529.01 DEFINITION.**

For purposes of this article, "bicycle" means a vehicle having two tandem wheels either or both of which has a diameter of twenty inches or more and propelled by human power. (Ord. 1585 § 1. Passed 6-18-62.)

**529.02 CLINGING TO MOVING VEHICLE PROHIBITED.**

No operator of a bicycle shall cling to any other moving vehicle. (Ord. 1245 § 6. Passed 3-4-40; Ord. 3091. Passed 4-28-03.)

**529.03 OBEDIENCE TO TRAFFIC CONTROL DEVICES; USE OF HAND SIGNALS.**

(a) Any person operating a bicycle shall obey the instructions of official traffic control signals, signs and other control devices applicable to vehicles, unless otherwise directed by a police officer.

(b) Whenever authorized signs are erected indicating that no right or left or U turn is permitted, no person operating a bicycle shall disobey the direction of any such sign, except where such person dismounts from the bicycle to make any such turn, in which event such person shall then obey the regulations applicable to pedestrians.

(c) The operator of a bicycle shall use appropriate signals with hand or arm to indicate his intention to turn to his left or right into or through another lane of traffic.

#### **529.04 YIELDING RIGHT OF WAY; PARKING.**

(a) The operator of a bicycle emerging from an alley, driveway or building shall, upon approaching a sidewalk or the sidewalk area extending across any alleyway, yield the right of way to all pedestrians approaching on such sidewalk or sidewalk area, and upon entering the roadway, shall yield the right of way to all vehicles approaching on such roadway.

(b) No person shall park a bicycle upon a street other than upon the roadway against the curb or upon the sidewalk in a rack to support the bicycle or against a building or at the curb, in such a manner as to afford the least obstruction to pedestrian traffic.

#### **529.05 RIDING NEAR RIGHT-HAND CURB AND IN SINGLE FILE.**

The rider of a bicycle upon a street or roadway shall ride as near as practicable within five feet of the right-hand curb or edge of the roadway except when passing a standing or other vehicle or making a left-hand turn at an intersection. All bicyclists shall ride in single file on the streets and highways within the City.

#### **529.06 RIDING ON HANDLE BARS; TRICK RIDING PROHIBITED.**

No operator of any bicycle, when upon a street or public place, shall carry any other person upon the bar, handle or other part of any such bicycle, and no other person shall so ride upon any such bicycle. No operator of a bicycle shall do trick riding, such as riding the same without having his hands on the handle bars when such bicycle is being operated upon any street or public place in the City.

#### **529.07 RIDING ON SIDEWALK PROHIBITED.**

No person shall operate a bicycle on any sidewalk in the City.

#### **529.08 LIGHTS AND REFLECTORS REQUIRED.**

Every bicycle when in use at nighttime shall be equipped with a lamp on the front which shall emit a white light visible from a distance of at least 500 feet to the front and with a red reflector on the rear of a type which shall be visible from all distances from fifty feet to 300 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle. A lamp emitting a red light visible from a distance of 500 feet to the rear may be used in addition to the red reflector.

#### **529.09 BRAKES.**

Every bicycle shall be equipped with brakes in good working condition.

Whoever violates any of the provisions of this article shall, upon conviction thereof in a summary proceeding, be fined not more than \$300.00 plus costs, or imprisoned for not more than 90 days, or both.

**530.01 OPERATION ON PUBLIC PROPERTY PROHIBITED.**

No person shall operate a motorized snowmobile, mini bike, go-cart or other unlicensed motorized vehicle on any of the streets, alleys, places, sidewalks or other public rights of way in the City.

**530.02 ISSUANCE OF OPERATION PERMITS AUTHORIZED.**

The Titusville Police Department is authorized to issue permits for the operation of the vehicles enumerated in Section 530.01, in case of emergency or other limited circumstances, as declared by the City Manager, or for special events approved by Council.

**530.99 PENALTY.**

Any person violating any provision of Section 530.01 shall, upon conviction in a summary proceeding, be fined not less than ten dollars (\$10.00), nor more than twenty-five dollars (\$25.00), for the first offense, and not more than three hundred dollars (\$300.00) for each and every offense thereafter, together with the costs of prosecution for each offense, to be collected as other fines and costs are by law collectible, and in default of payment thereof, shall be imprisoned for not more than ninety days, and the vehicle involved in the violation of Section 530.01 may be impounded during the period in which such fine remains unpaid and/or during the period of imprisonment.

**Skateboards**

The word "skateboard" when used in this article shall mean a narrow board mounted on rollerskate wheels, or the like.

**531.02 PROHIBITIONS.**

No operator of a skateboard, roller skates, roller blades, or scooter shall:

- (a) Cling to any other moving vehicle;
- (b) Violate the instructions of official traffic control signals, signs and other control devices applicable to vehicles, unless otherwise directed by a police officer;
- (c) Disobey the direction of any authorized sign indicating that no right or left or U turn is permitted except where such person dismounts from the skateboard, roller skates, roller blades, or scooter to make any such turn, in which event such person shall then obey the regulations applicable to pedestrians;
- (d) Fail to yield the right of way to all pedestrians on sidewalks or streets with the operation of such devices permitted on such sidewalk or street;
- (e) Fail to yield the right of way to all vehicles;
- (f) Leave a skateboard, roller skates, roller blades or scooter unattended on a sidewalk or street;
- (g) Operate a skateboard, roller skates, roller blades or scooter on a City street or alley except within five feet of the right-hand curb or edge of the roadway;
- (h) Operate a skateboard, roller skates, roller blades, or scooter on any sidewalk, Municipal parking lot or street located anywhere within the following area of the City: that area bounded on the north by Cherry Street, on the south by Oil Creek, on the east on Drake Street, and on the west by Second Street.
- (i) Operate a skateboard, roller skates, roller blades or scooter on any street, sidewalk or public place during hours of darkness.

**531.99 PENALTY.**

Any person who violates any provision of this article shall have his or her skateboard, roller skates, roller blades, or scooter confiscated and impounded for not more than fifteen days. In addition, any person violating any of the provisions of Section 531.02, upon conviction, shall be sentenced to pay a fine of not more than three hundred dollars plus costs of prosecution, and, upon failure to pay such fine and costs, to imprisonment not exceeding 90 days. **532.01 CLOSED TO VEHICULAR TRAFFIC.**

The segment of East Walnut Street commencing at a point east of North Brown Street where the east side of an alley way meets the north line of East Walnut Street to the west side of Petroleum Street shall be closed to all motor vehicular traffic other than emergency motor vehicles and necessary service motor vehicles.

**532.02 METHOD OF CLOSING.**

The section of East Walnut Street as set forth in Section 532.01 shall be closed pursuant to this article by the placement of breakaway bollards from the eastern side of the alley way across the width of East Walnut Street and the westerly portion of Petroleum Street. The breakaway bollards shall be placed in such manner as to not affect the orderly flow of traffic from the alleyway referenced in Section 532.01 and Petroleum Street.

**532.03 PARKING PROHIBITED.**

No person shall park a motor vehicle:

- (a) On East Walnut Street between the section of East Walnut Street as described in Section 532.01.
- (b) On East Walnut Street west of the bollards at any point within twenty feet of the breakaway bollards to be placed across Walnut Street.
- (c) On Petroleum Street within twenty feet of the breakaway bollards to be placed across Walnut Street on the west side of Petroleum Street.

**532.04 RIGHTS RESERVED.**

This article shall neither be construed nor have the effect of abandoning any easements or right of way for street or for water or for sewer lines the City may have under the above-described segment of East Walnut Street.

**532.05 PERMITS FOR SPECIAL CIRCUMSTANCES.**

The Titusville Police Department is authorized to issue permits for the operation of motor vehicles in case of emergency or other limited circumstances, as declared by the City Manager, or for special events approved by Council.

**532.99 PENALTY.**

Any person violating any provision of this article shall, upon conviction in a summary proceeding, be fined not less than ten dollars (\$10.00), nor more than twenty-five dollars (\$25.00), for the first offense, and not more than three hundred dollars (\$300.00) for each and every offense thereafter, together with the costs of prosecution for each offense, to be collected as other fines and costs are by law collectible, and in default of payment thereof, shall be imprisoned for not more than ninety days, and the vehicle involved in the violation of this article may be impounded during the period in which such fine remains unpaid and/or during the period of imprisonment.
